3. Professor Camille Gibson

Camille Gibson, Ph.D., C.R.C. holds both a Bachelor of Arts in Criminology and a Master of Arts in Rehabilitation Counseling from the University of South Florida in Tampa, Florida. She went on to earn a Master of Philosophy in Criminal Justice and a Doctor of Philosophy in Criminal Justice from the City University of New York where she studied at the John Jay College of Criminal Justice campus. She is a former Niederhoffer Memorial Fellowship recipient.

As a nationally certified rehabilitation counselor, C.R.C., she worked in various settings with juveniles in conflict with the law as the primary client. She has been a university faculty member for over 20 years – beginning at Brooklyn College for four and a half years in the Political Science Department and concurrently for three years at John Jay in the Public Administration Department. Since then, she has been at Prairie View A&M University, just outside of Houston, Texas for 19 years. She has chaired 11 dissertation committees to completion and served on over 50 such committees. She has several publications that include being author of

the book Being Real: Student-Teacher Interactions and African American Male Delinquency and co-author of Juvenile Sex Offending: What the Public Needs to Know. Her articles have addressed topics such as drug trafficking; gangs in schools; race and school suspensions, sexual abuse, sex trafficking, child abuse and juvenile violence. Her professional memberships include the American Society of Criminology, the Academy of Criminal Justice Sciences and the Southwestern Association of Criminal Justice.

Dr. Gibson is a past President of the Southwestern Association of Criminal Justice in which capacity she represented many criminal justice educators and researchers in Texas, Oklahoma, Arizona, Arkansas, New Mexico, and Colorado. In 2018, she finished three years of elected service on the national board of the Academy of Criminal Justice Sciences. She has offered advice internationally on juvenile justice. She is also the Communications Officer for the Caribbean Crime Study Group which meets biannually in the US. For this group, she is the editor of the Caribbean Diaspora Crime Prevention Gazette. In 2010-2011, she was part of a team of researchers that produced the Office of the Children's Advocate's Profile of Children in Conflict with the Law report in Jamaica.

Dr. Gibson was once a radio DJ of rap reggae and R&B. She hopes to resume engagement in dance when she finds free time.

Patsy Lewis is Senior Fellow at the Watson Institute for International and Public Affairs and Director of the Center for Latin American and Caribbean Studies (CLACS) at Brown University. She received her PhD and MPhil from Cambridge University (Trinity College) and BA from the University of the West Indies, Jamaica. She specializes in the political economy and development challenges of the Caribbean. Her published work has focused on the Caribbean Community (CARICOM) and the Organization of Eastern Caribbean States (OECS), in particular the role of these regional integration arrangements in addressing the development challenges of Caribbean small states. Her publications include *Pan Caribbean Integration: Beyond CARICOM* co-edited with Terri-Ann Gilbert-Roberts and Jessica Byron (Routledge 2018); *Grenada: Revolution and Invasion* co-edited with Gary Williams and Peter Clegg (University of the West Indies Press 2015); and Surviving Small Size: Regional Integration in Caribbean Ministates (University of the West Indies Press 2002). She was previously Professor of Regional Integration and Small States Development at the University of the West Indies, Jamaica.

9. Professor Rupert Lewis

Dr. Rupert Lewis is Professor Emeritus of Political Thought, Decolonising Political Theory and Comparative Politics in the Department of Government, University of the West Indies, Jamaica. He has earned an international reputation as a scholar of the Garvey movement and Caribbean radicalism in the twentieth century. In 2018 his biography of Marcus Garvey was published. He is author of the book *Walter Rodney's Intellectual and Political Thought* and has edited books on George Padmore, the Trinidadian-born Pan-Africanist and Richard Hart, the Jamaican Marxist. He is a member of Jamaica's National Council on Reparation.

She is currently working on her fifth book, "Archipiélagos de ultramar: Comparative Insular and Colonial Studies," which uses comparative archipelagic studies as a historical and theoretical framework to propose a research agenda for the study of cultural productions in the Caribbean and other colonial archipelagoes between 1498 and 2010. She is co-editor of the book series on Critical Caribbean Studies at Rutgers University Press.

12. Professor Kathleen Monteith



Kathleen E. A. Monteith is Professor of Caribbean History, University of the West Indies Mona Campus

She is the author of ground-breaking publications in the field of Business and Economic History, namely <u>Plantation Coffee in Jamaica</u>, 1790-1848, (2019) and, Depression to Decolonization: Barclays Bank (DCO) in the West Indies, 1926-1962 (2008). Other publications include several journal articles published in the Financial History Review, Slavery and Abolition, The Journal of Caribbean History and Plantation Societies in the Americas, along with coedited volumes, West Indian Business History: Enterprise and Entrepreneurship (2010); Jamaica in Slavery and Freedom: History, Heritage and Culture (2002).

In addition to her position of Editor of the *Journal of Caribbean History*, which is published twice annually in June and December on behalf of the three departments of History in the University of the West Indies, Professor Monteith is Chair of a number of Campus committees.

She is an active member of the Association of Caribbean Historians, for which she has served on the Executive, chaired the Nominating Committee, and also the prestigious Elsa Goveia Memorial Book Prize committee.

Professor Monteith began her career in the University of the West Indies in 1995 as an Assistant Lecturer. She gained her Ph.D. Degree in 1997), Centre for International Business History, Department of Economics, the University of Reading, UK, which was facilitated by the award of a British Commonwealth Scholarship. She holds an M.Phil. Degree, (1992) and a B.A. (History) Degree, 1986, Second Class Honours Degree (Upper Division) from the University of the West Indies, Mona Campus.

13. Dr. Natasha Mortley

Dr. Natasha Kay Mortley is a Lecturer and Research Specialist at the Institute for Gender and Development Studies, Regional Coordinating Office, UWI in Jamaica. Dr. Mortley is a Sociologist with extensive experience in the field of Gender and Development Studies.
